ABSTRACT

As an alternative method to the classical energy productions, the concept that energy can be consumed where it is produced has been successfully applied today to minimize the increasing energy costs and use more efficient and clean energy. Even though the fossil-based energy sources are gradually decreasing, they continue to harm the environment with many negative effects such as air, water, soil pollution and global warming. Protecting the environment from these harms, and reducing these negative effects has become the most important targets of many countries in the world. The solutions can be found via renewable energy sources by producing "green power". As these types of solutions increase, the ratio of greenhouse gas emitted at the atmosphere decreases, which is an extremely environmentally friendly approach. BIOMONITORING OF SO₂ SPATIAL DISTRIBUTION ON THE TERRITORY OF THE REPUBLIC OF MOLDOVA

ABSTRACT

Based on the Air Quality Assessment Grades (GECA) and the Lichens Toxicity Scale (STL) versus SO₂, developed by us, was tested the air quality, in 2007 and 2017, from 60 and 107 forest ecosystems and stations, respectively, in order to achieve air quality monitoring at national and international level by non-instrumental methods, for honoring Republic of Moldova's obligations under the Geneva Convention (1979). It was established that the moldavian forest ecosystems do not contain reserves to critical loads of SO₂ pollution, the annual average for the vegetation season for dendrological species is 0.02 mg / m³ air, and for communities of lichens and cyanobacteria (organisms sensitive to pollution) - only 0.01 mg / m³. Lichens indication demonstrated that the current level of air pollution with SO₂ is between 0.05 and 0.5 mg/m³, what indicates long-term, adverse effects, manifested in all studied forest ecosystems. Over 10 years, air quality has improved, particularly in the northern and central areas of the country, while the southern and south-eastern areas remained practically unchanged. Of the 107 ecosystems and stations, evaluated in 2017, it was found that in 10 forest ecosystems the air quality is assessed as *clean air*, 24 - *low polluted air*, 54 - *moderate polluted air*, 15 - *polluted air*, 4 - *high polluted air* and those with *critical polluted air*, were missing.

ABSTRACT

Due to today's competitive conditions and rising energy prices, the efficient use of energy consumed by facilities is only possible with the energy savings that can be made by investing in time, updating the technology, optimizing operating conditions and constant controlling. In this direction, The Bar Rolling Mill authorities have started this work to detect possible energy losses on the site and to increase energy efficiency. Measurements and evaluation of the results were made on the surface insulation inspections in annealing furnace, annealing furnace flue gas and annealing furnace cooling water, compressors, compressed air lines, pumps and annealing furnace burning air fan and hydraulic motors in Bar Mill. In the studies of the measurements, each equipment and line were examined separately and necessary calculations were done. Some suggestions were made on determined points which cause energy losses, how much loss is realized through these points and necessary investments to compensate for these energy losses, the price information. In the light of these works carried out in the factory; It is possible to save a total of 1,767,120.04 kWh/year energy and 441,780.01 ₺/year saving of money. Total investment cost is 558,500.85 ₺. The average return on investment (ROI) for all application plans is 1.26 years. After all these improvements, CO₂ emission values will be reduced to 1,030.23 tons per year.

ABSTRACT

In order to study the application of mathematical models in the analysis of the effect of planting density and weed interference on agronomic traits of different rapeseed genotypes, indicators including physiological feature, morphological feature, components and compounds of components of experimental rapeseed genotypes, in the terraces, which were broken twice, in the form of pilot plan of blocks, complete randomized, with 3 replications was conducted in Fars province (Darab city, Farrag district) in 2012-2013 (two years). The results of stepwise regression of grain yield (as dependent variable) on 12 agronomic traits were presented for two years. The results confirmed that pod weight and 1000-grain weight could well predict performance changes. In order to interpret the relationships between traits and grouping them, factor analysis was used based on these relationships. Factor analysis was carried out using principal components method on the traits studied in this experiment and the factors were given to Vermax 1 for better justification. In this analysis, the three main and independent factors justify a total of 88.48% of the total variance.

CORRELATION BETWEEN TGA-IGA LEVELS AND HYSTOPATHOLOGIC CHANGES IN CD: A STUDY IN COELIAC CHILDREN IN ALBANIA

ABSTRACT

Diagnosis of CD is based on a number of examinations; serologic testing and duodenal biopsies being the most important. Advances in serologic testing are raising the question if duodenal biopsy is always a necessary examination. The purpose of the study is to present the correlation between the serum level of TgA-IgA and the significant histopathologic changes in the intestinal mucosa. Also we will try to establish the cut-off value of TgA-IgA through which we can predict the presence of histological changes, Marsh 2 or more, in the intestinal mucosa. The study included 112 children diagnosed with CD in the department of pediatrics, clinic of specialties, from 2010 to 2016 with an age range from 6 months to 18 year old. Serologic testing and duodenal biopsy were performed in all patients. Histopathologic changes were interpreted according Marsh-Oberhuber criteria. To compare the diagnostic value of the tests, and to establish the cut-off values we used the ROC curve analysis. By analysing the average values of the TgA-IgA, TgA-IgG, AgA-IgA and AgA-IgG according to the stage of disease, Marsh 0 to Marsh 3 a/b/c confirmed with biopsy, we found that TgA-IgA titer increases significantly with progression of Marsh stage; whereas the increase of the other parameters (TgA-IgG, AgA-IgA and AgA-IgG) has no statistic significance, considering the correlation between increase of antibody titer and progression of Marsh stage. According to the data we found an increasing number of patients with elevated TgA-IgA ≥ 100 with higher Marsh stages confirmed with biopsy. Aproximately 14.3% of patients with biopsy stage M1 had TgA-IgA ≥ 100 . On the other hand in patients with M3 stage this percentage increases up to 61.5% (P=0.043). We clasified the patients based on the TgA-IgA titer in two categories; patients with TgA-IgA <100 and patients with TgA-IgA ≥ 100 . The data show that most of the patients with TgA-IgA ≥ 100 experience gastrointestinal symptoms, abdomianl distension, weight loss, failure to thrive and anemia, compared with patient with TgA-IgA <100. This suggests that higher titers of TgA-IgA are associated with severe manifestations of CD in children. For a limit value of TgA-IgA ≥ 76.85 the test has a sensibility of 70.3 % and a specificity of 85.7%. Acording to our analysis this is the best combination of the parameters and thus the established cut off value oh TgA-IgA. In this stydy we found a positive correlation between seric level of TgA-IgA and the histological changes compatible with CD in the intestinal mucosa.

COMBINING ABILITY FOR YIELD OF SOME LINES OF MAIZE SYNTHETIZED IN CONDITIONS OF THE MYZEQE REGION OF ALBANIA

ABSTRACT

According to Sprague and Tatum (1942), the estimate of combining ability (general and specific) is necessary to effectively exploit the heterozygosity and synthesis of new hybrids. Sprague and Tatum (1942) defined general combining ability (GCA) as “the average performance of a line in hybrid combinations” and defined specific combining ability (SCA) as “those cases in which certain combinations do relatively better or worse than would be expected on the basis of the average performance of the lines involved”. The methods of using these indicators were later elaborated by other authors such as Griffing, Eberhart, Hallauer, etc. This paper gives the results of the estimate of the combining ability for the yield of 15 inbred lines of the maize selected in Agroarfa Lushnja, Albania. The lines were synthesized by the self-pollination maize hybrid of the class 600, the most widespread hybrid in the Myzeqe region. One of the aims of the work was the evaluation of different hybrids cultivated so that they can be used effectively as a base material in the creation of new maize lines adapted to the conditions of this area. It is known that this region has a dry and hot climate. Selected lines are of six inbred generations which represent good agronomic indicators as well they resulted the best ones in the testcross analyzer. From the diallel analysis of the combining ability it results that from these hybrids are created four lines of interest for general combining ability and four lines with specific combining ability. Lines 9 and 11 are presented as candidates to enter in the collection of lines that can be used for producing hybrids. From this study it turns out that hybrids that fit well into production conditions can be a good source for creating suitable lines in the conditions of a given area.

ABSTRACT

The dental cysts are formed from different reasons and can grow in becoming huge with time. We are showing a case where cystectomy was the treatment of choice, to accelerate healing and minimize the possibilities or reformation or infection during the healing. The cystic hole left, was filled using a combination of grinded tooth and synthetic particles of β -TCP granules. The grinded tooth was obtained after extraction of a retained canine 43 and treated with Smart Dentine Grinder. The extraction was done in the same session with the cystectomy. The mixed particles was treated with the BCGF system from venous autologous blood to became in a sticky consistency and are enriched this way with growth factors and more to accelerate healing. We have called this material “Sticky Tooth” since the autologous tooth and blood derivate were used. The case has a 1 year follow up showing the symptomless clinical and CBCT result of the final healing allowing a final prosthetic treatment.

ABSTRACT

Existence of chemical pollutions and heavy metals in the environment, especially in surface and ground waters is followed by enormously harmful effects on public health. For the purpose of elimination of these pollutions, several methods including implementation of CNTs and active carbons yielding from agricultural wastes have been used. Considering the industrial variability of the city of Saveh, every year a large amount of polluting chemical wastewater enters the environment. The purpose of the present study was to eliminate the Nickel heavy metal and pollutions caused by mineral compounds through making use of pomegranate peel wastes for production of active carbons. For this purpose, various parameters such as pH, contact time, absorber amount, primary density of the metal, and Freundlich and Langmuir's adsorption isotherms, as well as the overall experiment scheme were studied and investigated using the Design Expert Software. Results of the study showed that a pH of 8 is associated with the highest absorption level. In addition it was tuned out that by prolonging the contact time up to 50 minutes, more than 84.2% of the Nickel content is absorbed by the absorber. The obtained experimental data are in a roughly desirable consistence with the Freundlich and Langmuir's isotherm models. The values yielded by the optimization of factors were evaluated in order to obtain an optimum elimination efficiency solution and a high selectivity percentage. In order to obtain the selectivity of 0.691 and the optimum elimination efficiency of 91.7432, the value of pH must be equal to 8, contact time must be 50 minutes, and the primary density must be 75mgs per liter.

ABSTRACT

In this paper, the demand of the energy carriers in Iran is analyzed and modeled for the country's largest consumer, buildings and related industries, in the status quo and future perspective. To this end, the building sector is divided into two sections: household section (residential buildings) and services (business-office and service buildings) according to the ISIC classification, each of which is subdivided into other sub-sections. In addition, building-related industries include some non-metallic minerals and basic metals industries. Given that scenario-based energy planning helps to increase the understanding of different probabilities in the future, the future perspective of the system is modeled according to the 2035 horizon using the LEAP modeler in the "reference" scenario, which indicates continuation of the status quo of the energy system in the future. The results of the modeling indicate an increasing demand for energy as so it is expected that the demand for energy carriers in buildings and related industries to reach up to 1040.6 million barrels of oil equivalents in 2035, from 559.8 million barrels in 2014. Therefore, in order to reduce energy consumption, solutions are modeled and analyzed according to the scenarios for "Improvement of energy consumption in buildings and related industries", and then the greenhouse gas emissions and their environmental impacts are examined.

ABSTRACT

This study was conducted with three replicates at six different junctions facing dense motor-vehicle traffic to investigate the usability of ornamental plants in the prevention of environmental pollution in Erzurum in Turkey. *Tulipa sp.* (*Tulipa* ‘Banja Luka’, *Tulipa* ‘Golden Parade’, *Tulipa* ‘Pink Impression’, *Tulipa* ‘Margarita’, *Tulipa* ‘Antarctica’, *Tulipa* ‘Hakuun’, *Tulipa* ‘Escape’, *Tulipa* ‘Darwidesign’) plants and soil around their roots were taken on planting (pre-test) and fading (30 days after plantation, post-test) periods, and heavy metal accumulation was investigated in the soil around the roots of the plants and in their leaves and flowers. Eight types of heavy metal (Cr, Mn, Fe, Co, Cu, As, Cd, Pb) contents of the samples (soil, leaf, and flower) were analyzed through Inductively Coupled Plasma Mass Spectrometry (ICP-MS). The mean and standard deviations of the variables were determined conducting the T-test in the SPSS program and the statistical significance levels of the results obtained were determined using the ANOVA test ($p < 0.01$). Post-test levels of Co, Cr, Fe, and Cd in plant samples (all three parts) were found to be statistically significant ($p < 0.01$) at A2 (Havuzbaşı) and A1 (Gez) junction points, which receive the densest traffic. However, Fe, Cr, Cu and Mn ion levels of soil at A4 (University entrance) and Yenişehir junctions, where the traffic density is lower, were found to be not significant in post-tests. The reason for this is thought to be the addition of soil from outer sources when placing bulbs. Considering the increase rate (%) in Cr between pre- and post-tests, it was found that the largest change was seen in flower petals (436%; from 1.25 mg kg^{-1} on planting to 6.70 mg kg^{-1} 30 days later), followed by leaves (505% from 1.94 mg kg^{-1} to 11.74 mg kg^{-1}) and soil (63% from 40 mg kg^{-1} to 65 mg kg^{-1} at pre- and post-tests); these differences are statistically significant. At A1 point, the increase between the measurements of leaves for Mn was found to be 226% (from 29.25 mg kg^{-1} to 95.22 mg kg^{-1}); for Fe in flower petals at A4 point, the increase was 855% (from $866.26 \text{ mg kg}^{-1}$ to $8274.56 \text{ mg kg}^{-1}$); Co levels in leaves at A4 point increased by 863% (from 0.43 mg kg^{-1} to 4.14 mg kg^{-1}). This study is the first to be conducted on *Tulipa sp.* in Turkey. This study is important because it was determined in the study that the plant investigated provides not only aesthetical and visual contributions to landscape architecture, but it also has a possible function of being a hyper-accumulator depending on the rate of heavy metals it contains in its body parts. Usability and functionality of the plant to this aim were also discussed. Struggling with environmental pollution is a heritage to be dropped for the future. Therefore, wise solutions to preventing pollution are vitally important in the respect of economic development, rehabilitation of polluted areas and sustainable use of all the areas for the futures of countries.

ABSTRACT

In the long residential field experiments revealed the dynamics of total long-humus black soil, depending on the recruitment and placement of crop rotation, tillage, fertilizer type and its dosage. Given the forecast changes to humus content in typical black soil humus under different farming systems main components by 2050. Done age excursion into the past and look to the future in the age cycle. The level of humus accumulation during the execution of various processing systems is most significantly changed in the first years after the beginning of the experiment, then the humus content is stabilized and changes very slowly with time as a result of the transition of humus formation to a quasi-equilibrium state with degradation phenomena. The use of various methods for treating chernozem of typical low-humus for 42 years only led to a delay in the processes of dehumification and to some extent stabilized the mineralization of humus, but did not contribute to its preservation and extended reproduction to the initial level at the time of the experiment. The increase in humus content occurs with respect to plowing and a control option without fertilizers. The increase in the content of total humus for simple and extended reproduction of humus in the secular cycle is equivalent to 20-25 tons per 1 ha and 30-33 tons per 1ha, respectively. To ensure established increases in humus, it is necessary to annually introduce manure 10-12 tons per 1 ha for simple and 14-15 tons per 1 ha of extended reproduction of the total humus content annually.

ABSTRACT

Objectives: Diabetes is a chronic disease characterized by decreasing insulin secretion due to impairment of the function of beta cells in the pancreas or increased insulin resistance. The tendency to treat diabetes by herbal medicines, which has less side effects than chemical drugs, is spreading day by day. High blood glucose levels in chronic diabetes mellitus cause multiple complications including increased inflammatory factors such as TNF- α and a decrease in leptin levels in blood and other tissues. Therefore, it is important to reduce the destructive effects of these factors. Herbal drugs are considered to reduce complications of diabetes. In this respect, the positive effects of hydroalcoholic extract of *Calendula officinalis* in some tissues have been observed and it has been suggested that it may be effective in reversing the levels of leptin and TNF- α . Therefore, in this study, the effect of *Calendula officinalis*'s extract on blood glucose, TNF- α , and leptin was evaluated by experiments on diabetic male rats. **Materials and Methods:** Sixty male Wistar rats considering 300-250 g were separated into 6 groups in equal and random order: healthy group, diabetic group, diabetic group with normal saline gavage, and three diabetic groups receiving extract of *Calendula officinalis* with doses of 100, 150, and 250 mg / kg. Diabetes was persuaded by injection of 60 mg / kg Streptozotocin (Sigma-Germany). The duration of treatment of rats was 4 weeks. To measure the variables, after anesthetizing the animals, the blood sample was collected to define the levels of TNF- α and leptin by ELISA, and the fasting glucose levels by an enzymatic method. **Results:** The body weight of diabetic rats after 4 weeks of intervention was significantly less than that of control rats, and treatment with extract of *Calendula officinalis* had no important effect on the weight of rats. Meanwhile, persuaded diabetes significantly increased abstaining blood glucose in diabetic groups than in the control group. In diabetic groups receiving the extract of *Calendula officinalis*, fasting blood sugar decreased significantly in compression to diabetic control group. TNF- α levels increased in diabetic condition, and behavior of diabetic rats with extract of *Calendula officinalis* decreased this inflammatory factor. Serum leptin decreased by induction of diabetes than healthy control group, and the extract of *Calendula officinalis* did not significantly affect the level of this cytokine. **Conclusion:** The extract of *Calendula officinalis* showed some of the anti-diabetic properties such as decreasing blood glucose and anti-inflammatory effects, and reduces TNF- α , which is an important inflammatory marker for the pathogenesis of diabetes, with no significant effect on serum leptin levels.

ABSTRACT

Increases of heavy metals in soils are harmful to the environment and human health. Heavy metals in soils originate from both natural and anthropogenic sources. Zanzan province in Iran due to industrial and mining activities is susceptible to increasing of heavy metals. This paper investigated heavy metals concentration in 296 composite soil samples in Zanzan Province. Enrichment Factor (EF) and Geoaccumulation Index (Igeo) calculated for each soil sample to determine the soil quality. EF results show low enrichment in heavy metals except Pb and Zn. Igeo calculated for each sample and results indicated that most samples have no pollution except for Pb, Zn, and Cu. For the understanding of pollution pattern in the study area, the spatial distribution of heavy metals based on EF values evaluated and location of pollutants were determined. Results showed main pollutants were located in central part and western part of this area where industrial stated and mines have activities related to heavy metal.

ABSTRACT

Postpartum depression (PPD) is the most common medical complication of childbearing. Universal screening PPD maximizes the likelihood of prompt identification of it. Based on evidence PPD occurs in 10 to 15% of new mothers. Groups of women at higher risk include (50–60%) inner city women, mothers of pre-term infants and adolescents. Depression after delivery persists for more than 7 months in 25–50% of women. Post-birth depressive episodes may result in maternal social or relational problems even after recovery. In this paper, we are presented the relation of PPD with factors like age, demography, marital status and education level. The methodology we used is Edinburgh Postnatal Depression Scale (EPDS). This self-report instrument contains ten items ranked from 0 to 3 that reflect the patient's experience over the past week. The EPDS has been validated extensively for use in the postpartum period and during pregnancy. In this study are involved to be evaluated for PPD, patients from 4 primary health care centers in Tirana and from two departments of Obstetrical Gynecology University Hospital "Geraldine Queen" in Tirana and to find out the Frequency of depression by time after birth at the target group of this study. Patients that participated in the survey are anonymous in accordance to respect patient's right.

ABSTRACT

The content and stocks of carbon and the activity of microbiological destruction of organic matter in three types of chernozem soils in Ukraine have been investigated. An imbalance was found in the accumulation of the main components of the soil organic matter, as well as between mineralization processes, humus accumulation and degradation of cellulose in arable soils and their natural analogs. In the soil of natural ecosystems, the processes of mineralization-immobilization, destruction of organic matter and humus accumulation are balanced, which is confirmed by a high carbon pool (C_{tot}) and a fraction of C_{mic} in C_{tot} . In the soil of natural ecosystems processes of mineralization-immobilization, destruction of organic resources and humus-accumulating are balanced, which is confirmed by high-quality carbon pool and partial C_{mic} in C_{tot} . In agroecosystem is going destabilization of organic matter in the soil, which leads to a decrease of humus content in 1.1-1.5 times, stocks of organic matter - in 1.3-1.8 times. In arable soils, part of C_{org} in the total soil carbon pool is 80-82% and 92-94% in the soil of the natural ecosystem. The losses of C_{org} from chernozem soils in agroecosystem are 19-29% and this is due to a significant reduction in the content of C_{mic} (63-71%). The application of different fertilizers causes destabilization of the soil microbial community, reduces microbial productivity and activates mineralization processes of organic matter, which leads to loss of C_{org} and a decrease in the total carbon pool (C_{tot}) in the soil by 6-18%. The soil of natural ecosystems is characterized by a high content of C_{mic} in the C_{org} (3.14-3.70%), which indicates a high microbial productivity and fixation of organic substances in biomass of microorganisms. In the arable soils, was the low content of C_{mic} in the organic matter of the soil (1.19-1.52%) which indicates the predominance of mineralization processes over the processes of humification. The application of exogenous mineral substances in the soil activates the processes of mineralization (K_{min} increases by 7-18%) and provides a high degree of using by microorganisms of soil organic matter (K_{ped} increases by 6-9%). Organic fertilizers contribute to the formation of a maximum microbial pool, optimizing the structure of soil microbial community, decrease the intensity of mineralization processes (K_{min}) by 15-29% and the decomposition of soil organic matter by 6 to 37%. A significant difference in the parameters of the potential cellulolytic activity of the soil in the natural ecosystems and agroecosystems had been established. At the same time, the soil of natural ecosystems is characterized by a slight fluctuation of the emission CO_2 (3.3-4.4 mg CO_2 / kg of soils per day).

THE EFFECT OF CLIMATIC PARAMETERS AND SEASONAL VARIATION ON AREA PREFERENCES OF DAIRY GOATS IN CONVENTIONAL LOOSE HOUSING WITH OUTSIDE ENCLOSURE

ABSTRACT

Barn design taking into account barn area preferences and welfare of animals plays an important role for goat milk production. Although area preferences and behaviour indices were studied for cattle, behaviour indices for goats is unavailable. The aim of this study was to defined, as a novelty in the literature, goat behaviour indices and to investigate the hourly and seasonal changes in the barn area preferences of Saanen dairy goats and seasonal variation of defined behaviour indices of the goats (207 animals) in conventional housing with outside enclosure. Animals were monitored using continuous video record (24 h per d) in the housing during a year. By using a 60-min scan sampling technique, the animals were videotaped for a total of 30 d (720 h) in summer, autumn and winter. The design of the study contained the hourly and seasonal variation of four different barn area preferences (resting, courtyard, feeding and watering area). Temperatures, relative humidity and temperature and humidity index (THI) were evaluated at five-minute intervals. As new goat behaviour indices, the values of the goat comfort index (GCI), the eligible goat comfort index (EGCI), the goat stress index (GSI), and resting area usage index (RUI) was defined and calculated. A factorial experimental design was used to analyse all behavioural data. The dairy goats preferred using the courtyard (open area) at a higher rate (73.3, and 65.7%) to the resting area (closed area) for resting and standing except for winter ($P<0.01$). GCI for summer, autumn and winter were 0.003, 0.030, and 0.636 whereas GSI for same seasons were 0.137, 0.125, and 0.127, respectively ($P<0.01$). Development of alternative new barn design taking into account area preferences and behaviour indices instead of conventional housing is important to increase milk production and welfare of goat.
